FIVE IMPORTANT TIPS TO PREPARE FOR FAMILY BUSINESS TRANSITIONS IN SOUTH DAKOTA



Most families create their wealth through private business enterprise. However, owners of family businesses are aging. A recent study suggests that approximately 60 percent of all business owners are over age 55 and nearly one-third are over age 65.

WHAT TO CONSIDER REGARDING BUSINESS TRANSITIONS

Whether you are considering selling the business to a third-party buyer or moving the business to your family's next generation, here are 5 important tips that you should consider well before the eventual business transition.

PLAN EARLY

A business plan should be put in place at least 3-5 years ahead of any expected transition. A good first step is for everyone to recognize the value of early business transition planning.

BUILD AN EXPERIENCED TRANSITION TEAM

A good transition plan requires expertise in many different areas. Attorneys, accountants, bankers, financial planners, and insurance advisors can all provide helpful planning expertise. It's important to select a team of professionals who have worked with similar businesses and have experience in transition planning, navigating family dynamics, and understanding the financial and emotional aspects of business transitions.

DEVELOP A WRITTEN PLAN AND TIMELINE

It is important to make a written plan with clear objectives and a timeline for implementing each stage of the transition. Each objective should include a series of "action steps" that keep the transition moving forward. It is critical that clear criteria be used to evaluate the success of the plan and that the timetables are being followed.

TRAIN YOUR FAMILY SUCCESSORS AND WORK WITH THEM

You cannot expect your family to take over and operate your business successfully if you don't spend any time training them. Your transition plan will have a better chance of success if you train your family successors for a couple of years before you "hand over the reins."

This is often difficult, but it's definitely time well-spent and will make a big difference for a successful transition.

LOOK AT YOUR SUCCESSORS REALISTICALLY

You may want your oldest daughter to run the business, but does she have the business skills - or even the interest - to do it? Maybe there's another family member who is more capable. It may even be that there are no family members capable of or interested in continuing the business and that it would be best to sell it. Examine the strengths of all possible successors as objectively as possible and think about what's best for the business.



5 QUESTIONS ABOUT SEALING A CRIMINAL RECORD IN SOUTH DAKOTA



QUESTION #1 WHAT IS A SUSPENDED IMPOSITION OF SENTENCE?

A suspended imposition of sentence seals your criminal conviction and does not require a judgment of guilt. It may be used in certain cases for both a felony and a misdemeanor crime.

QUESTION #2 AM I ELIGIBLE FOR A SUSPENDED IMPOSITION OF SENTENCE?

Maybe. However, to be eligible, you must have no prior felony conviction.

QUESTION #3 IF I RECEIVE A SUSPENDED IMPOSITION OF SENTENCE, IS MY CRIMINAL RECORD SEALED?

Yes (under most circumstances). Receiving a suspended imposition of sentence seals your record to the public - i.e. employers, insurance companies, federal student aid, etc. However, a suspended imposition of sentence does not hide your record from law enforcement or the courts.

QUESTION #4 IF I RECEIVE A SUSPENDED IMPOSITION OF SENTENCE, CAN I STILL BE PLACED ON PROBATION?

Yes. A court can still place you on probation upon certain terms and conditions.

QUESTION *5 AM I AUTOMATICALLY ENTITLED TO RECEIVE A SUSPENDED IMPOSITION OF SENTENCE?

No. A court has the ultimate discretion to grant or deny a suspended imposition of sentence.

BAKED BUFFALO CHICKEN DIP

INGREDIENTS:

- 3 c. diced cooked chicken
- · 2-8 oz. packages cream cheese, softened
- 3/4 c. hot pepper sauce
- 1/2 c. shredded Pepper Jack cheese
- 1/2 c. blue cheese dressing
- 1/2 c. crumbled blue cheese
- 1/2 tsp seafood seasoning
- 2 tbsp Pepper Jack cheese
- 2 green onions, chopped

DIRECTIONS:

- 1. Preheat oven to 400°F
- 2. Combine all of the ingredients in a 9" baking dish
- 3. Sprinkle 2 tbsp Pepper Jack cheese on top
- 4. Bake until lightly browned, 15 to 20 minutes. Remove from oven and garnish with chopped green onions

HOMEMADE AVOCADO CHIPS

INGREDIENTS:

- 2 large ripe avocados
- 1-1/2 c grated Parmesan cheese
- · 2 tsp lemon juice
- 1 tsp garlic powder
- 1 tsp Italian seasoning
- Kosher Salt
- · Fresh ground black pepper

DIRECTIONS:

- 1. Preheat oven to 325° and line a baking sheet with parchment paper
- 2. Mash avocados until smooth. Stir in remaining ingredients. Season with salt and pepper to taste.
- 3. Drop by heaping teaspoon 3" apart then flatten
- 4. Bake until crisp and golden, 20-25 minutes.
