Q: In South Dakota, what happens to my grandfather's property if he dies without a Will?

A: A person who dies and has a Will is said to have died testate. When a person dies without a Will, the court appoints a personal representative to administer the estate and to distribute the property, as provided by law.


When there is no Will, there will be an intestate probate proceeding. These proceedings are generally in the county where the deceased lived at the time of death. If there is no Will, the persons entitled to share in the distribution of an estate are determined by the rules of intestate succession.

Q: South Dakota Business Law: What are the standard mileage rates for 2016?

A: The Internal Revenue Service recently issued the 2016 optional standard mileage rates used to calculate the deductible costs of operating an automobile for business, charitable, medical or moving purposes.

Beginning on Jan. 1, 2016, the standard mileage rates for the use of a car (also vans, pickups or panel trucks) will be:

- 54 cents per mile for business miles driven, down from 57.5 cents for 2015
- 19 cents per mile driven for medical or moving purposes, down from 23 cents for 2015
- 14 cents per mile driven in service of charitable organizations
